The Governance handbook is guidance from the Department for Education. It should be read alongside the DfE's 'Competency Framework for Governance' which describes the knowledge, skills and behaviours needed for effective governance. The Handbook focuses on key governance and educational policy updates to support governors and is a key resource for reference. There is significant work to be done to get all pupils back on track following the pandemic, which means the role of governors in monitoring how core school budgets, catch-up funding and Pupil Premium are being spent has never been more vital.

Governing effectively can only happen when schools/Trusts have people with the necessary skills and knowledge on each governing board and where those boards are accessing support and independent advice from professional sources. For 2022/23 Learners First has continued its partnership with the National Governance Association (NGA) to offer a programme of professional development that is as accessible as possible and supports the three core purposes of effective governance:

- Ensuring clarity of vision, ethos and strategic direction;
- Holding executive leaders to account for the educational performance of the organisation and its pupils, and the effective and efficient performance management of staff; and
- Overseeing the financial performance of the organisation and making sure its money is well spent.
